
1. Sanction is accorded to:-

- i) Grant of extension in the period of recognition in favour of 25 Private Educational High/Higher Secondary Institutions of Kashmir Division for the period as mentioned against each, forming Annexure "A" to this order.
- iii) Up-gradation/affiliation in favour of 43 institutions of Kashmir Division upto High/Higher Secondary level for the period as mentioned against each, forming Annexure "B" to this order.

2. This sanction is, however, subject to condition that Director, School Education, Kashmir and Secretary, J&K BOSE have strictly followed all rules and guidelines pertaining to grant of affiliations with regard to extension in recognition and up-gradation issued from time to time and management of these institutions shall fulfill all deficiencies as indicated by Affiliation Committee, against each in annexures to this order, within three months from date of issuance of this order, failing which extension in recognition/up-gradation granted shall be treated as withdrawn/cancelled ab-initio without any further notice.

3. This sanction shall be further subject to fulfillment of following conditions:-

- i) This recognition is co-terminus with period of affiliation granted by J&K BOSE/Affiliation Committee.
- ii) Compliance to conditions prescribed in NOCs issued by the Competent Authorities in general and School Education Department in particular pertaining to safe transportation of children, boarding/de-boarding arrangements, deployment of



- personnel for the purpose and formulation of proper traffic management plans, etc
- iii) Strict compliance to directions/decisions of the Committee for regulation/Fixation of Fee structure constituted by the Government.
 - iv) Adherence to terms and conditions of affiliation orders issued by J&K BOSE.
 - v) This recognition/up-gradation approval is liable to be withdrawn/cancelled in case there is violation or non adherence to prescribed conditions.




